## **EuSpRIG 2006 – Spreadsheets and Corporate Compliance conference goes up to Cambridge**

Many studies have shown that organisations of all sizes fail to perform thorough checks that spreadsheets critical to their business are free of material error. In some cases, significant sums of money are lost. Regulating authorities are taking a keen interest as it becomes increasingly clear that Banks, Financial Institutions and other large corporations are exposed to these risks. Neglecting to manage spreadsheet risks is no longer a matter confined to the profit and loss account, but may lead to breaches of regulatory requirements, and place directors and managers at significant personal risk.

The European Spreadsheet Risks Interest Group (EuSpRIG) was established in response to these problems and is holding its 2006 conference on the theme of “**Managing Spreadsheets: Improving corporate performance, compliance and governance**” on the 6th and 7th July 2006 at Fitzwilliam College, University of Cambridge, Cambridge, UK.

The keynote speakers are Dean Buckner of the **Financial Services Authority**, who will be speaking on the use of spreadsheets in the financial markets and Professor Tom Grossman of the **University of San Francisco**, who will be speaking after the conference dinner.

There are 18 papers and presentations over the one and a half day conference. Brandon Weber of **Microsoft Corporation**, USA is presenting an invited paper entitled “Strategies for Addressing Spreadsheet Compliance Challenges”. Other topics include “Recommended Practices for Spreadsheet Testing”, “A New Approach to Spreadsheet Analytics Management in Financial Markets”, “Managing Spreadsheet Systems”, “A Software Development Methodology for Research and Prototyping in Financial Markets” and “Spreadsheets in Clinical Medicine”. Speakers and delegates are expected from Europe, the USA and Australia.
